It is our pleasure to extend an invitation to your step team to participate in Klash of The Greeks IV ("KOTG"). Our show is based on the unique concept of Old School vs. New School. Alumni, undergraduate and All - Star step teams of Greek - Letter organizations will be allowed to compete in this event. The competition will be split into two divisions: Sorority and Fraternity. There will be 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place for each division. However, only the 1<sup>st</sup> place winner of each division will receive a cash prize of \$2000.

Enclosed are complete registration and event details. The registration deadline is March 1, 2009. Your registration is not complete until your fee is received. Feel free to circulate this packet to other interested Greek letter organizations.

# RULES & REGULATIONS

1. Each team is required to pay a non-refundable **registration fee of \$125.**
  - a. **Due by March 1, 2009.**
2. A completed registration packet must be submitted by each team.
  - a. Return a complete participation agreement with the registration form and fee.
3. All teams will compete in either the fraternity or sorority division.
4. There will not be a separate division for alumni, undergraduates, or all – star teams.
5. The Bond Production Group, LLC will determine the order of performance for all teams.
6. There will be nine judges, representing each organization of the National Pan-Hellenic Council.
  - a. If a judge fails to attend the event, that judge will not be replaced and those points will be forfeited by all teams.
7. The highest and lowest score for each team will be dropped prior to score tabulation.
  - a. The total scores from each judge will be added and a grand total will be tabulated for each team
  - b. The team with the highest score will be declared the winner.
  - c. There are 900 possible points.
8. Each team will have **10 minutes** to complete their performances, inclusive of Intro and Exit steps.
  - a. Five points will be deducted when time has been exceeded by 1 – 29 seconds.
  - b. Ten points will be deducted when time has been exceeded by 30 – 59 seconds
  - c. Any time exceeding one minute will result in Disqualification.
9. Scoring reductions will be allowed by reasons of profanity and sexually explicit material not to exceed a total of 10 points.
10. Each team must have all music cued on one CD.
  - a. You must provide one person to instruct the sound technician during your team's performance.
11. Only actual participating step team members, one sound person, and one light person will be admitted with your registration fee. All others must pay admission.

12. All stage props must be approved by **March 7, 2009**.
13. If a team member is reported or observed as having a physical confrontation or provoking a conflict, the team he/she represents will be disqualified.
14. If a team member or team delays or causes disruption to the event, that team will be disqualified.
15. Use of any type of fog, smoke, fire, laser or pyrotechnics related devices is **NOT** allowed.
16. In the event of a tie in 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup> place, the prize of that category will be split between the tying teams and that "place" will be announced a tie.
17. Each team will have an optional stage walk through and music check between 4:30pm – 6:30pm
  - a. The Bond Production Group, LLC will provide each team a designated "walk through" time.
  - b. If you choose not to walk through during this time, no other opportunity will be available to you.
18. All selected teams must report to all scheduled meetings on the day of the event.
19. Each team will be photographed as a team prior to the event and ALL teams will be photographed at the conclusion of the event
20. Prizes for each Division:
  - a. 1<sup>st</sup> place - Winner Takes All \$2000
  - b. 2<sup>nd</sup> place – Trophy
  - c. 3<sup>rd</sup> place – Trophy
21. The rules are subject to change. If any changes occur, all teams will be notified in a reasonable amount of time.
